	iii)	Exchange Duration	Single semester exchange is recommended.
	iv)	Examination	There is no overlapping of academic terms with NUS. Students will not be allowed to leave early due to commitments at home such as work placements, internships, etc. All exchange students are expected to complete the examination / assessment at the University College Cork before returning to NUS.

	vi)	Minimum Requirements to Apply	 i) have completed a minimum of one year's undergraduate study at NUS; ii) have GPA of 3.0/4.0 and above (equivalent to NUS CAP of 3.75/5.0 and above) in order to be eligible for the exchange at University College Cork; or have a minimum 'B' average grade or 65% - 70% average marks or ranking in the top one-third of the class; and no single grade below 'C' in the current/intended discipline/major;
