| <b>Minimum application requirements</b> | <p>Exchange applicant should:</p> <ol style="list-style-type: none"> <li>1. Be nominated as a Non-Graduating Exchange (NGE) student from a <a href="#">university-wide exchange partner university</a> for the Student Exchange Programme (SEP)</li> <li>2. No grade below “C” in the major of studies. Preferably an average of “B” grade in the declared major of studies at home university for better chances of securing modules amidst competition from other applicants</li> <li>3. Have completed at least one year of study at the home university before applying to NUS for the coursework-based exchange programme</li> <li>4. Not be in their graduating year/ semester of studies while on exchange</li> <li>5. Be competent in the English language and able to communicate effectively in both academic and social settings</li> <li>6. Show the aptitude, motivation and maturity, to thrive in the environment at the host university</li> <li>7. Have the financial means to pay for the living expenses (e.g. accommodation, food, transport, etc.) and maintain a reasonable standard of living throughout the exchange duration</li> </ol> |

| <b>English proficiency</b>          | English is the main language of instruction in NUS. Students from non-English medium universities applying to read Law modules, are required to submit <a href="#">TOEFL or IELTS</a> result.  |
| <b>Non-English language courses</b> | Students can take any of the language courses offered by the Centre for Language Studies (CLS) subject to qualification and availability. Students are required to provide a letter from their home university to declare their level of proficiency in the language(s). <a href="#">Placement tests</a> may be required for higher level language modules.  |
| <b>Modular System</b>               | Workload in the NUS modular system are expressed in Modular Credits (MCs). The usual load for NUS students is 16 to 20 MCs per semester, where 1 MC is equal to 2.5 hours of study and preparation per week. A 4-MC module requires 10 hours of work a week, including lectures, tutorials, laboratory sessions, assignments, and independent or group study. | <b>Types of Module Grading Basis</b> | <p>All modules secured at the point of offer are set to examinable by default. Exchange students have to seek the permission from their Home University before they can set an examinable module to audit. Modules set to audit might not be allowed for credit transfer back at the Home University. Some modules cannot be set to audit.</p> <p>For modules set to audit, student can attend lectures and will not be allowed to sit for examinations. Participation in other practical components (e.g. tutorials, laboratory work, and fieldwork) will be at the discretion of the respective academic faculty/ department.</p>   |
| <b>Grading System</b>                | <p>Students may refer to <a href="http://www.nus.edu.sg/registrar/education-at-nus/modular-system.html">http://www.nus.edu.sg/registrar/education-at-nus/modular-system.html</a> for NUS' grade table. The grading system for the modules taken in NUS can be found at the back of the official NUS transcripts. There is no corresponding mark range for each grade.</p> <p>Upon request, the academic advisers will share the grades for Continuous Assessment (CA) such as regular assignments and project work with students throughout the semester. However, the grade for the final examination cannot be shared as explained in the <a href="#">NUS' grading policy</a>. CA constitutes a significant percentage of the final grade for many NUS modules.</p> |

| <b>Guide on modules selection and application</b>                          | <p>Students are advised to read the <a href="#">online guide</a> on modules selection and application before applying for the exchange at NUS.</p> <p>In general, the first number in the module code indicates the year of study, except for general electives modules with prefix GEHXXXX, GEKXXXX, GEMXXXX, GEQXXXX, GERXXXX, GESXXXX, or GETXXXX. Majority of the general elective modules do not have pre-requisites.</p>  |
| <b>Minimum and maximum number of modules to be taken for each semester</b> | <p>Exchange students are required to read a minimum of 12 modular credits (MCs) per semester (approximately 3 modules) and no more than 20 MCs (approximately 5 modules), regardless of whether these modules are set to audit or examinable.</p> <p>Students are encouraged to take modules for sufficient number of credits (<i>not in excess</i>), as required by their home university. Please take note that a 4-MC module requires 10 hours of work a week.</p> <p>All students will be pre-registered for 12 modular credits (MCs) per semester during the application stage for the purpose of Student's Pass application. Students can add more modules or make changes to their pre-registered modules when they arrive at NUS.</p> |
| <b>How are modules approved by NUS?</b>                                    | <p>Approval of modules is given by the respective NUS Faculties/ Schools / Departments based on the following key factors:</p> <ol style="list-style-type: none"> <li>1. Compatibility of chosen module with declared major of studies;</li> <li>2. Fulfilment of modules' pre-requisites;</li> <li>3. Availability of the modules; and</li> <li>4. Class and Examination timetabling</li> </ol> <p>Students are required to provide their latest academic transcripts. Transcripts should include the list of modules taken at home universities, their respective grades and a <b>grade legend</b>. Please seek the approval from your home university if you wish to take modules unrelated to your major or your level of studies while on exchange.</p> <p>Time-table clashes increase when students take modules from two or more different Faculties/Schools.</p>   |
| Are course schedules/timetables available online?  | Class timetables for the new academic year are available at <a href="https://webrb.nus.edu.sg/ctt/builder.aspx">https://webrb.nus.edu.sg/ctt/builder.aspx</a> in July. The timetable will also be updated around end of November. Please check the timetable for approved modules to ensure that there is no clash of class and examination date and time.   |
| <b>Graduate modules restriction</b><br><br><b>(MUST READ)</b>  | <p>Modules of Level 5000 and above are graduate modules and are <b>NOT</b> offered to undergraduate students. Graduate modules found on <a href="#">the list of modules</a> are reserved for students coming under specific graduate exchange agreement.</p> <p>Business modules with prefix BMXXXXX are only available to graduate students nominated under NUS Business School faculty-level exchange agreement.</p>   |

| <p><b>Undergraduate modules restriction</b></p> <p>Please refer to <a href="#">Modules Restrictions</a> for more details.<br/><b>(MUST READ)</b></p> | <p>Due to overwhelming demand, incoming students who wish to enrol in <b>Economics and Psychology</b> modules might not be able to secure their required number of modules in these disciplines. In order to increase the chances of securing a minimum of 12 MCs worth of modules to support the Student's Pass application, students who require <b>Economics and Psychology</b> modules need to consider alternative modules offered by other departments/schools during application.</p> <p>More details on module restrictions are as follows:</p> <p><b>Business</b></p> <ul style="list-style-type: none"> <li>• By invitation only.</li> <li>• Exchange students who are unable to secure any Business module at the time of application, will not be able to enrol for any Business module when they arrive at NUS. <u>NUS Business School manages a separate module system which is only open to Business exchange students invited by NUS Business School.</u></li> </ul> <p><b>Law</b></p> <ul style="list-style-type: none"> <li>• By invitation only.</li> <li>• Only elective Law modules (i.e. with prefix LL4XXX) are available.</li> <li>• Elective Law modules carry a weight of 4, 5 or 8 credits each with majority of the modules worth 5 credits each.</li> <li>• Exchange students with Law as one of their majors must secure <u>at least 2 Law modules per semester</u> at the point of offer in order to be invited by NUS Law via email for <a href="#">Law module registration</a> separately.</li> </ul> <p><b>Economics</b></p> <ul style="list-style-type: none"> <li>• Economics modules at NUS are more Mathematics-based. | <p><b>Are modules at NUS guaranteed for exchange students?</b></p>   | <p>There is <b>no guarantee</b> that exchange students will secure their required/preferred modules. Students should choose from the list of modules available to exchange student from the <a href="#">module list</a> as modules not found on the list are not open to exchange students.</p> <p>We encourage interested students to consult their academics on the modules which they can read at NUS before applying for the exchange. Students will experience less stress if they are allowed by their Home University to <b>be flexible with their modules choices</b>.</p> <p>If the matching of available modules is not suitable to meet the graduation requirements at the home university, then students should not submit the exchange application to NUS.</p>  |

Nominations and applications received <b>after the deadlines may not be processed</b> in time for exchange in the respective semester.</p> |

Nominated students should apply as “<b>Non-Graduating Exchange (NGE)</b>” students for fee-waiver exchange. <p>Academic counselling is the responsibility of the home university. Follow the Study Plan approved by the home university and choose up to 10 <u>relevant</u> modules in the online application in order to maximise the chances of securing at least 12 modular credits per semester. Applicant who makes a voluntary health declaration in the online application form should support the declaration with a doctor's certification/letter if special assistance is needed while at NUS. The type of assistance provided by NUS will be limited to the availability of resources. Please refer to our <a href="#">Disability Support Office</a> for more information.</p> <p>5. Applicants should indicate on their initial exchange application if they require on-campus accommodation. If applicants indicate that they do not require accommodation or leave the answer blank on their applications, they will <u>not</u> receive an invitation to apply for accommodation in the online offer letter.</p> <p>6. | <p><b>Application outcome</b></p>  | <p>Students will be contacted via email if there are missing documents to support their exchange applications or they have to reselect the modules. Students can check their application status via the online portal or wait for the notification of outcome via email in mid-June (for exchange in August) or end of November (for exchange in January).</p>   |
| <p><b>Acceptance of offer and upload photo</b></p>   | <p>Students are required to indicate acceptance of offer and upload their latest photo that meet the requirements set out <a href="#">here</a>, for the purpose of the NUS Student Card (file size 125KB in jpg format).</p>   |
| <p><b>Confirmation of pre-registered modules</b></p>   | <p>Successful applicants can view their pre-registered modules at the online application portal using their Application ID and password around mid-June (for August intake) and around end of November (for January intake).</p>   |
| <p><b>Modification to pre-registered modules allocated to students at the point of offer</b></p> | <p>Students need to maintain a minimum of 12MCs per semester (including modules set to audit) in order for NUS to sponsor their Student's Pass. The pre-registered modules at the point of offer are essential for the application of Student's Pass prior to the official registration at NUS. <b>Students are advised not to modify the pre-registered modules before the "Add/Drop" exercise.</b></p> <p>The module "Add/Drop" exercise happens during the first two weeks of every semester. More information on modules modification can be found in the <b>NUS Registration Guide</b> which will be sent together with the offer email.</p> <p>Before coming to NUS, students are advised to check the <a href="#">timetable</a> for all pre-registered modules. | Are exchange students required to obtain a visa (Student's Pass)?      | <p>Yes. Exchange students who have been accepted to NUS will receive instructions via email for the Student's Pass application.</p> <p>Students who need a visa to enter Singapore will receive the scanned In-Principle Approval (IPA) letter via email from NUS Registrar's office and can use the letter as a single-trip entry visa. All other students will be instructed to enter on a tourist visa and then convert it to a Student's Pass during registration.</p> |
| Will NUS assist in the completion of formality for the Student's Pass? | Yes. The information can be found in the <a href="#">NUS Registration Guide</a> . The link to this guide can be found in the online offer letter from NUS Registrar's Office.  |
| Fees for Student's Pass  | <p>Entry visa application fees cost S\$30 for all students who requires an entry visa.</p> <p>Students who do not require entry visa, pays about S\$60 to S\$90 for the Student's Pass.</p>  |
| Is a medical report required?  | Yes, for <u>full-year exchange students</u> to support the application of Student's Pass. Students should complete a medical examination using the form provided by Singapore's immigration. Full-year exchange students can arrive in Singapore earlier to do their medical check-up at NUS or print out the given medical form and have the check-up done at their home country. Details will be provided in the <a href="#">NUS Registration Guide</a> .                |

| Are exchange students required to purchase a compulsory medical insurance plan? | Yes. Every international student must take up the compulsory NUS Health and Insurance Scheme (HINS) which is included in the Miscellaneous Student Fees (MSFs). | How about travel insurance? | All registered NUS students (including Non-Graduating students) will be covered under a <a href="#">blanket travel insurance</a> . This insurance covers students for official NUS trips taken during exchange. It is highly recommended that exchange students purchase personal travel insurance for their own travel. |



## On-campus Accommodation

| <p><b>Is university accommodation guaranteed for exchange students?</b></p>                                  | <p><b>No.</b> Due to shortage of on-campus accommodation at NUS, exchange students are <b>NOT guaranteed</b> on-campus accommodation. With increasing numbers of incoming exchange students, it is very likely that you need to source and secure your own private and off-campus accommodation.</p> <p>NUS receives more exchange students in Semester 1 (August to December); therefore it is more difficult to secure on-campus accommodation in Semester 1. <b>Prospective students who are able to come on exchange in Semester 2 are strongly encouraged to do so.</b></p> <p>Non-exchange student and graduate exchange students will <b>not</b> be considered for on-campus accommodation application. Research student should consider staying at private, off-campus accommodation.</p>   |
| <p><b>How will I know if I am eligible to apply?</b></p>   | <p>If you are eligible to apply for on-campus accommodation, the offer email/letter from Registrar's Office will include an invitation to apply for accommodation along with the instructions and deadlines on how and when to submit your application.</p> <p>If you do not receive an invitation to apply for accommodation, the offer email/letter will include information on off-campus accommodation options. Please read the application <a href="#">instructions</a> and <a href="#">deadlines</a>.</p>   |

| <p><b>Administrative procedures to follow once students have been invited to apply for accommodation</b></p> | <p>To apply for on-campus accommodation, students must pay the non-refundable application fee of S\$26.75. Completed application will be reflected as '<b>pending</b>' in the <b>University Hostel Management System (UHMS)</b>. Successful applicants will receive an accommodation offer via email. The student will then need to login to UHMS to <b>accept the offer and pay the full accommodation fee</b> by the deadline(s) in order to secure the room.</p> <p>Students who fail to pay by the stipulated deadline, will automatically forfeit their allocated room and the room will be given to the next student on waiting list immediately. | <p><b>Is on-campus accommodation available over semester breaks?</b></p>                                     | <p>Yes, subject to availability. | <p><b>Opening a bank account in Singapore</b></p>                                   | <p>Exchange students may open a bank account in Singapore even if they are not staying for 6 months and above. Some banks in Singapore might charge an “Early Account Closure Fee” ranging from S\$20 to S\$30 for closing a bank account.</p> <p>DBS Bank at Yusof Ishak House in NUS requires a photocopy of the IPA letter for opening a bank account. All other banks in Singapore requires students to produce their Student’s Pass.</p> <p>Students who do not wish to open a bank account are advised to bring enough cash to last at least the first month of their stay in Singapore. Subsequently, they can withdraw additional cash at the numerous ATMs machines / cashpoints on campus and around Singapore.</p> <p>Students who have accounts with international banks that have branches in Singapore can find out from their bank directly about the charges for using their account in Singapore.</p>   |
| <p><b>Can student on exchange work part-time to supplement costs of living?</b></p> | <p><b>No.</b> Exchange students holding Student’s Pass sponsored by NUS for coursework-based exchange are <u>not</u> allowed to work without a valid work pass. This includes, but is not limited to, any form of external training attachment at any commercial venue, or an internal training attachment in any venue that serves the public.</p> <p>Students who wish to work after their exchange term ends have to be qualified for the (i) mainstream work passes; or (ii) Work Holiday Programme; or (iii) Training Employment Pass. A work pass is required even if there is no salary or allowance from the employer. The employer should assist the students in applying for the valid work pass from Singapore’s <a href="#">Ministry of Manpower</a>, before engaging them in any form of non-classroom training.</p> <p>It is an offence under Section 5(1) of the Employment of Foreign Manpower Act for anyone to engage or use the service of international exchange students who do not have valid work passes.</p> |

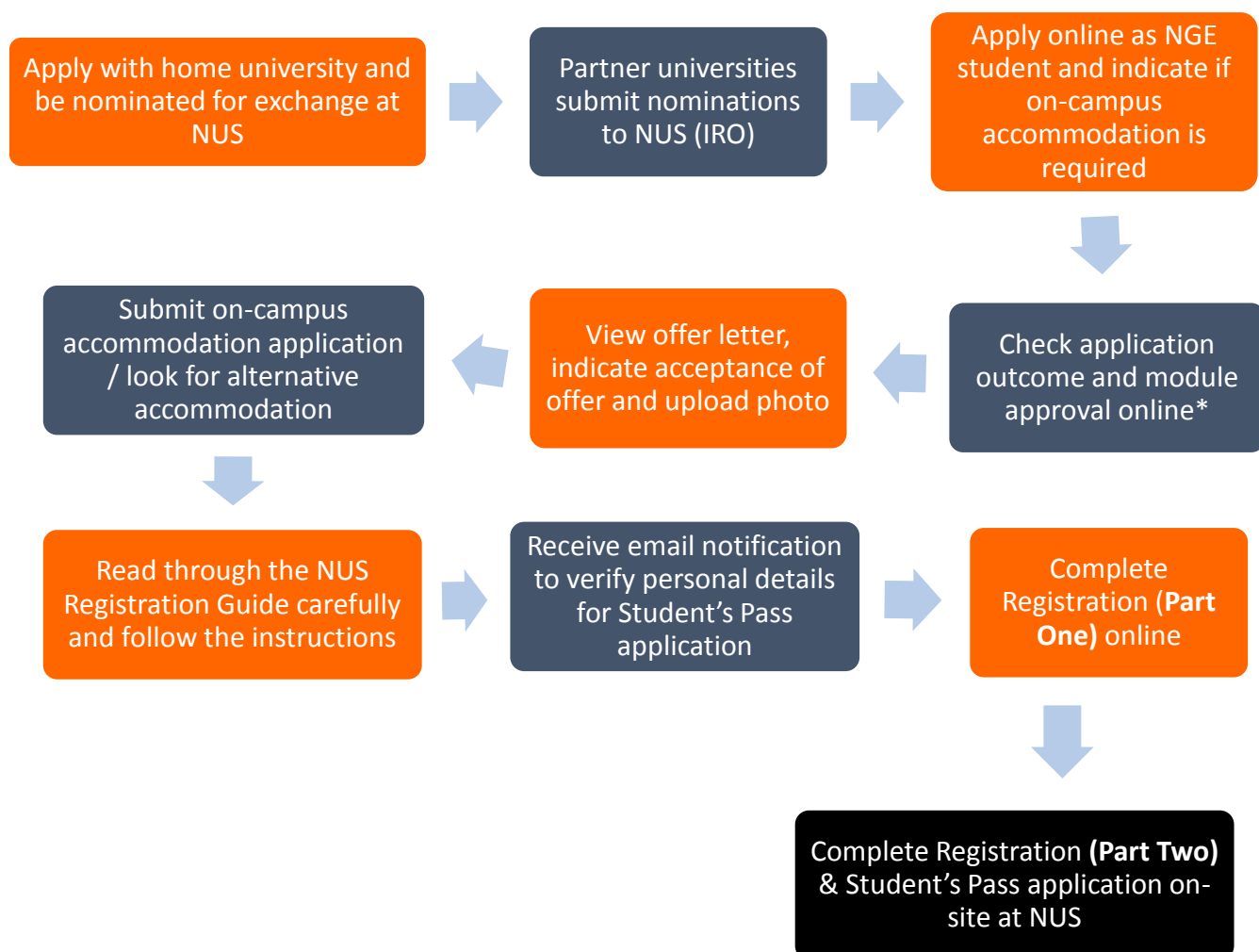
