

OVERSEAS STUDENT PROGRAMME LOAN APPLICATION FORM

INFORMATION

1. All students who are Singapore citizens and enrolled in full-time undergraduate courses of study can apply for the Overseas Student Programme Loan (OSP Loan).
2. The Application Form should be typewritten or legibly written in block letters.
3. The guarantor must be Singaporean citizen at least 21 years of age and shall not exceed 60 years of age.
4. The guarantor cannot be a full-time student.
5. Applicant is only allowed to apply once in his/her course of study in NUS.
6. Applicant and his/her guarantor are required to provide the completed Application Form, their identity cards, a copy of applicant's faculty/department programme approval letter and a copy of applicant's partner university programme approval letter (if applicable).

8. The maximum repayment period is 5 years. Interest computation is deferred until after graduation. Thereafter, average prime rate of 3 local banks applies, prevailing on the first day of each quarter. Repayment can be in one lump sum or in fixed equal monthly installments comprising both principal and interest (minimum of \$100 per month), commencing not later than 2 years after graduation and shall be made through OCBC Bank. Payment of monthly installment shall be made on 1st day of each month.
