Goh Choon Phong joined Singapore Airlines in 1990 and has held senior management positions in Singapore as well as overseas. Mr Goh joined the Airline's Board on 1 October 2010 and was appointed CEO on 1 January 2011.

Mr Goh became Executive Vice-President Marketing and the Regions in June 2010. Prior to that he was President of Singapore Airlines Cargo for four years. Previous senior positions with Singapore Airlines included Senior Vice-President Finance, Senior Vice-President Information Technology and Senior Vice-President Commercial Technology. His overseas assignments were in China and Scandinavia.

Besides Mount Alvernia Hospital, Mr Goh is a Board Director of SIA Engineering Company, a Member of the Steering Committee of the National Council of Social Service, a Member of the Board of Governors of the International Air Transport Association, and a Director on the Board of Virgin Australia Holdings Limited.

Mr Goh holds a Master of Science degree in Electrical Engineering and Computer Science as well as three Bachelor of Science degrees, in Computer Science & Engineering, Management Science and Cognitive Science, all from the Massachusetts Institute of Technology.

Ng Wai King is the Joint Managing Partner of WongPartnership and, concurrently, heads up the Corporate Group. Mr Ng maintains an active practice in mergers & acquisition and private equity transactions.

Mr Ng spent the better part of September and October 2010 advising Singapore billionaire Peter Lim on his bid to acquire Liverpool Football Club. A long suffering supporter, he was much disappointed when Liverpool was eventually sold to yet another group of American owners.

Working on the largest M&A transaction in Singapore's corporate history, Mr Ng led the team in advising TCC Assets and Thai Beverage Public Company Limited (a company listed on the Singapore Exchange) on a successful takeover offer for Fraser & Neave, Limited ("F&N"), fending off a competing offer by another party. The offer valued F&N at approximately S\$13.8 billion and the transaction was awarded "M&A Deal of the Year" for both South East Asia and Singapore, as well as "SE Asia Deal of the Year" at the ALB SE Asia Law Awards, 2014; and "Best M&A Deal" at the IFLR Asia Awards, 2014.

Mr Ng is currently advising JTC Corporation, a Singapore government statutory body, on a proposed merger with Temasek Holdings Limited of four of their operating subsidiaries to create a global urban solutions platform.

Mr Ng graduated from the National University of Singapore with an LLB (Hons) where he was awarded the AV Winslow Prize. He subsequently obtained an LL.M. from Columbia University School of Law where he graduated as a Harlan Fiske Stone Scholar. He teaches certain aspects of Corporate Finance Law at the Faculty of Law, National University of Singapore.
