3	Content	The Intensive Islamic Finance (IIF) programme will introduce students to a comprehensive understanding of the differences and similarities between the Islamic and conventional financial markets, the structure of the Islamic capital market, and Islamic financial products in Malaysia. The IIF programme equips students with knowledge about the history and development of Islamic banking and finance, shedding light on its principles and practices exploring the principles of Muamalah for Islamic economics and finance, and emphasizing ethical and Shariah-compliant approaches to financial transactions.				
		Additionally, the course addresses contemporary issues such as Islamic social finance and disruptive technology in Islamic finance, providing insights into how technology is transforming the industry. Furthermore, students will gain insights into wealth management strategies within the context of Islamic finance principles and familiarize students with various Islamic financial products prevalent in Malaysia, preparing them for careers in the dynamic field of Islamic finance.
