# **Participant Cancellation Policy**

All cancellation requests must be submitted in writing via email to the Organiser at <a href="microplastics@nus.edu.sg">microplastics@nus.edu.sg</a> and received by 4 September 2025. Cancellations will only be considered effective upon receipt of a written acknowledgement from the Organiser.

Registration fee refunds will be processed as follows:

- (i) For written cancellations received on or before 4 September 2025, 50% of the registration fee will be refunded.
- (ii) For written cancellations received after 4 September 2025, no refunds will be issued.

Refunds will be processed as soon as reasonably possible after the Symposium.

Please note that failure to obtain a travel visa does not qualify for a refund.

### **Registration Terms and Conditions**

These terms and conditions ("Terms") apply to all individuals registering as participants ("Participants") for the Symposium on Microplastics in the Environment and Water: Challenges, Research, and Mitigation Strategies (MP Symposium 2025), to be held in Singapore from 18 to 19 September 2025 ("Symposium"). The Symposium is jointly organised by the National University of Singapore (NUS Environmental Research Institute and Centre for Water Research) and SG Lab Forum (collectively, the "Organiser"). By submitting a registration for the Symposium, either personally or through a representative, the Participant agrees to be bound by these Terms.

#### **Changes and Cancellation by Organiser**

The Symposium is planned as an in-person event in Singapore. However, if the Organiser is unable to proceed as scheduled due to pandemics (including adherence to prevailing safe management measures) or other major unforeseen circumstances, the Organiser reserves the right, at its sole discretion, to transition the Symposium to a virtual format or to cancel the event in accordance with applicable government regulations. The Organiser also reserves the right to cancel, postpone, or modify the format, location, or programme of the Symposium as necessary.

The Organiser shall not be liable for any changes, postponements, or cancellations of the Symposium that arise from circumstances making the event impracticable or impossible to conduct. Participants acknowledge and agree that the Organiser will not be responsible for any loss or inconvenience resulting from such changes.
